Spring Tuition Charges:

The spring 2020 billing statements were electronically sent to all registered students on January 7th with a due date of February 1st; **any remaining balance after that date is subject to finance charges.** All students will have an email sent to their Augsburg email account during the first week of each month reminding them to view their online monthly bill; all students are encouraged to give parents/guardians access to view these statements by logging into Inside Augsburg/Records and Registration/Information Release.

Online Payments:

Payments can be made online by going to <http://www.augsburg.edu/studentfinancial/payments/>. Students can go to <http://www.augsburg.edu/studentfinancial/> and click on "Review Your Student Account" to see if they have an unpaid balance.

Payment Plans: Students can still enroll in the Online Payment Plan at

<http://www.augsburg.edu/studentfinancial/payment-plans-and-discounts>. However, they must enroll by January 27th to have their remaining balance divided into four payments.

Please note that we will be unable to speak with any parent/guardian that has not been authorized by the student.

2019 Tax Preparation:

Students will be notified when their 1098-T is available for their 2019 tax preparation. Students will be able to view the form by logging on to AugNet Records and Registration and clicking on Make Payment/Account Activity. The 1098-T tax form can be found on the bottom right-hand side of this page.

Private Loans Still Available:

PLUS (Parent Loan for Undergraduate Students) and other private loans can still be applied for at <https://www.augsburg.edu/studentfinancial/loans/undergraduate-day-2/>. Please note that all PLUS or private loan applications can take up to two weeks to process/be received by Augsburg.

What is FERPA?

FERPA (Family Educational Rights and Privacy Act) is a federal law designed to protect the privacy of educational records. FERPA rights belong to the student. Students who wish to authorize Augsburg University to talk with any other individual on their behalf must complete the online Information Release in AugNet Services/Records and Registration. Students can authorize access to any of the following: - Financial Aid/Finances (charges, credits), Grades/GPA, Academic (academic progress, advising).

Missing Financial Aid Documents:

All financial aid documents for the current academic year (2019-2020) should now be turned in. ***The final deadline to turn in documents is May 1st. Failure to meet this deadline will likely result in a loss of federal and state financial aid.*** It is important that students contact our office if they have not yet completed their financial aid application or if they have concerns about meeting this deadline.
