DAY-BY-DAY ITINERARY

SAT 27 MAY

Depart USA Your meaningful journey to the Holy Land begins today. Depart Minneapolis/St. Paul and connect at JFK with the overnight, transatlantic flight to Tel Aviv aboard Delta Air Lines. (Meals in-flight)

SUN 28 MAY Arrive Tel Aviv/Netanya Upon late afternoon arrival at Ben Gurion Airport, you will be met by your guide and driver. Transfer to a hotel at Netanya for dinner and overnight. (Meals in-flight, D)

MON 29 MAY

Netanya/Galilee

On the Mediterranean coast tour the site of Caesarea, once the Roman capital of Palestine. See the Crusader fortifications, the Roman amphitheater, aqueduct, and the harbor from where the Apostle Paul was taken to Rome. Lunch in Caesarea at the Port Café. Proceed into the valley of Megiddo. See the shaft and tunnel made by one of the twenty civilizations that built cities on this land. Drive to your hotel on the Sea of Galilee for dinner and overnight. Scots Hotel (B, L, D) www.scotshotels.co.il

TUE 30 MAY

Galilee

Visit the "Jesus Boat" followed by a boat ride on the Sea of Galilee. See the Ancient Synagogue and St. Peter's House at Capernaum; this is where Jesus healed Peter's mother-in-law and others. Drive along the shore to Tabgha for visits to the Church of Multiplication, built on the site of the Miracle of the Loaves and Fishes; and the Church of the Beatitudes, one of the most beautiful in the Galilee. Continue north to Caesarea Philippi, Mt. Hermon and the Golan Heights. Scots Hotel (B, D)

WED 31 MAY

Galilee

Morning departure for Nazareth. Stop at the precipice overlooking Jesus' hometown of Nazareth. See the Church of the Annunciation and Mary's Well. Then tour Nazareth Village, a living history farm and village that presents the life, times and teachings of Jesus. Visit the archaeological site at Bet She'an where excavations have revealed ruins of major archaeological significance; the history of the site goes back into the 4th millennium B.C.E., through King Saul's time, the Roman era and right up to the 21st Century. Return to the hotel for dinner and overnight. Scots Hotel (B, D)

<u>THU 01 JUN</u>

Galilee/Bethlehem

Travel to Bethlehem and upon 9:30A arrival meet for an introduction to Diyar Ministries with Angie Saba, and tour the International Center of Bethlehem (ICB) and Christmas Lutheran Church, then visit Dar al-Kalima University College and Dar Al-Kalima Health and Wellness Center. Meet with Pastor Mitri Raheb (subject to availability) to learn about the varied ministries of the Diyar Consortium and how the church empowers Palestinians by fostering training for employment, and creativity among local children. This afternoon visit Herodion – the hilltop castle and tomb built by Herod the Great. Drive to Hebron to visit the Tombs of the Patriarchs (traditional burial site of Abraham and Sarah) at the Ibrahimi Mosque. Hotel check-in and dinner. FRI 02 JUN Bethlehem This morning meet with a settler at Efrat Israeli Settlement and visit Deheishe Refugee Camp. Visit Shepherds' Fields at Beit Sahour where you will view Bethlehem as the might have on the night of Jesus' birth. Return to Bethlehem for a walking tour of the Old City, including a visit to the Church of the Nativity and Manger Square. St. Gabriel Hotel (B, D)

ou are invited on a Holy Lands journey that will bring the Bible alive and also encounter the lives of people now living in Israel/ Palestine. We will visit places associated with the Old and New Testaments, the life of Jesus and the early church from Galilee to Jerusalem and more. Along with the biblical stories, with close attention to history

and archaeology, we will also engage people: Jews, Christians and Muslims, working to find paths to peace in Israel/Palestine. An added distinction in this journey will be spending time in Bethlehem visiting not only the Church of

SAT 03 JUN

Travel through the Jordan Valley to ancient Jericho to view the Mount of Temptation and the site of the oldest city in the world. In Jericho see where Zacchaeus climbed a sycamore tree to see Jesus as he passed through the town (Luke 19:1-4). Drive to Masada and take the cable car to the top. On this rocky plateau, the Zealots held their last resistance against the Roman conquerors. Visit the Dead Sea - there will be time for an optional float in this unique body of water at the Ein Gedi spa. Stop at Qumran to see the caves where the Dead Sea Scrolls were found. Conclude your day with a relaxing Bedouin-style dinner before returning to Bethlehem for overnight. St. Gabriel Hotel (B, D)

SUN 04 JUN

Bethlehem/Jerusalem View the Separation Wall as you travel through the checkpoint to Jerusalem. Attend the English language worship service at Lutheran Church of the Redeemer in Jerusalem followed by fellowship. Embark on a walking tour of the Old City along the Via Dolorosa to experience the Stations of the Cross, viewing the last few Stations located inside the Church of the Holy Sepulchre. End the day in the tranquil surroundings of the Garden Tomb. Check in at your hotel for dinner and overnight. Notre Dame Center (B, D) www.notredamecenter.org/?page_id=188

MON 05 JUN

This morning visit the Temple Mount/Haram al Sharif and see the golden Dome of the Rock, an important symbol of the Muslim faith (inside visits not permitted). Walk through the Jewish quarter to see the Roman cardo and the Western Wall, considered to be one of the holiest sites in Jewish tradition. This evening there will be a presentation by a representative of the Parents' Circle of both Israeli and Palestinian bereaved parents. Notre Dame Center (B, D)

TUE 06 JUN

Jerusalem/Departure Ascend to the Mount of Olives to visit Augusta Victoria Hospital and learn about the healing work provided to Palestinians by this arm of Lutheran World Federation. Enjoy a breathtaking view of Jerusalem before walking down the Palm Sunday Road to the Garden of Gethsemane and Church of all Nations. Visit with the English-speaking pastor at Lutheran Church of the Redeemer and learn about the work of the Evangelical Lutheran Church in Jordan and the Holy Land (ELCJHL). There will be a bit of time for last minute shopping. Gather for a farewell dinner this evening. Note that hotel rooms will be available until departure. After dinner transfer to the airport for flight check-in and departure after midnight. Those going on the optional extension will remain overnight at the hotel. Notre Dame Center (B, D)

WED 07 JUN

Jerusalem/Petra

Petra

This morning transfer to the Allenby Bridge crossing to Jordan and meet your Jordanian guide, driver and coach. Drive to Mount Nebo where Moses viewed the Promised Land and enjoy the dramatic view of the Jordan Valley, Jericho and the Judean hills beyond. Then visit the village of Madeba to see the ancient mosaic map of the Holy Land. Continue through the vast desert to the village of Wadi Musa, which embraces the entrance to Petra - one of the Seven Modern Wonders of the World. Petra Guesthouse (B, D) www.guesthouse-petra.com

THU 08 JUN

Jerusalem

Two thousand years ago the Nabateans carved a city out of rose red rock and it was rediscovered in 1812. Today you will discover the formerly lost city of Petra during a guided tour. Begin by walking through the dramatic "ciq" or canyon that opens upon the Treasury, El Khazneh, one of the most elegant remains of antiquity. Beyond El Khazneh the visitor is surrounded on both sides by hundreds of Petra's carved and built structures. Enjoy a full day of touring this amazing, once-hidden world. Petra Guesthouse (B, D)

FRI 09 JUN Petra/Amman/Tel Aviv/Departure

Depart on the northbound journey to the Jordanian capital city of Amman. Meet with members of the local Lutheran church. Then visit Bethanybeyond-the-Jordan, which has received recognition as the likely site where John baptized Jesus. Nearby visit the new Lutheran chapel. Cross the Allenby Bridge and meet a local guide and driver. Stop for dinner en route to the airport. Arrive at Ben Gurion for flight check-in and departure after midnight. (B, D, Meals in-flight)

SAT 10 JUN

Arrive USA

Connect this morning at JFK with the continuing flight to Minneapolis/St. Paul. Arrive home this same day enriched with a new understanding of the ancient world and the Bible. (Meals in-flight)

TOUR CONDITIONS

PAYMENT SCHEDULE: Your reservation and deposit of \$400 per person are requested immediately to fulfill the group deadline requirements. Note that space is limited and reservations are taken on a first come, first served basis. A second payment of \$1000 is due January 20, 2017. Final payment is due March 23, 2017. For credit card payment Group Travel Directors accepts Visa, MasterCard, or Discover.
