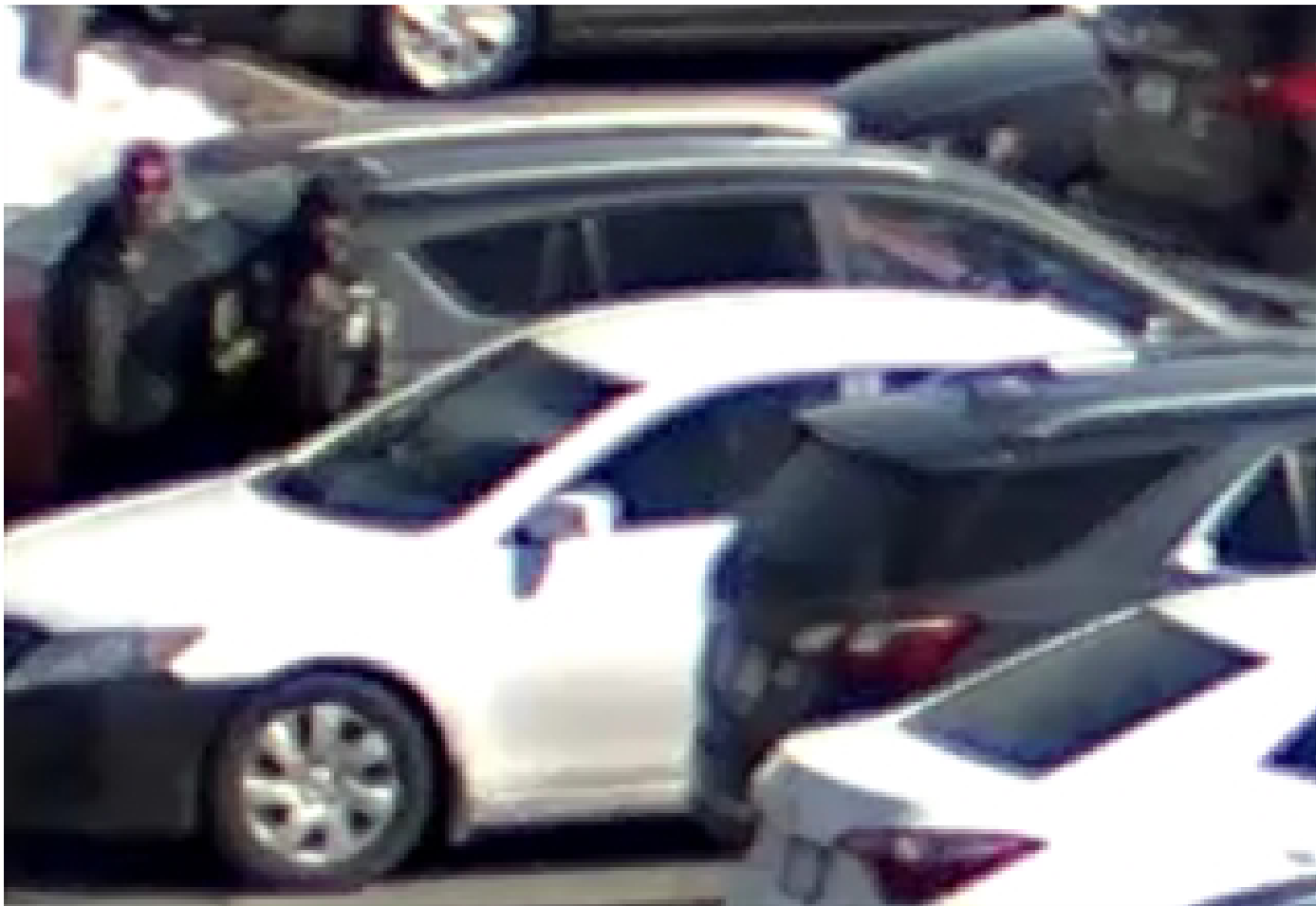

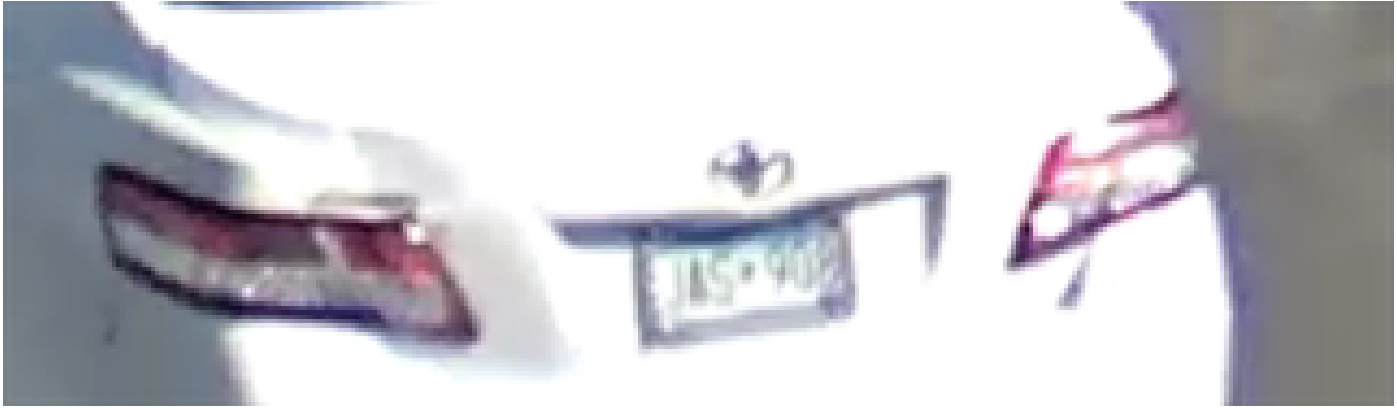

**Narrative text**

On 3/23/2023 at approximately 1516 I Officer Hartkopf and Officer PETERSON (115) were dispatched to take a report of a attempted motor vehicle theft.

Myself and 115 arrived in Lot L and met with SCHACK, JAGGER. SCHACK explained that he parked his vehicle at approximately 1400-1415 on campus and arrived at approximately 1510 and found his passenger rear window broken in. SCHACK stated that nothing was taken but the steering column was taken apart. SCHACK was able to start his vehicle and it appeared that there was no damage to the vehicles safety features i.e. turn signals.

Dispatch called MPD who advised that since there was no evidence or camera footage that no officer would be dispatched to take report, and advised SCHACK to call 311. We informed SCHACK and asked if there was anything further for us to do. SCHACK declined and stated he would call 311.

When checking the camera footage myself and 115 remember that prior to the call, we noticed a motor vehicle driving at a seemingly excessive speed coming from Lot L on Butler that then drove against the flow of traffic . It was a white Toyota sedan and had a distinct color pattern of a black front bumper cover with the rest of the vehicle being seemingly all white.

On the camera footage we found the same vehicle entering the lot at approximately 1501 said vehicle entered Lot L from 25th Ave S at a seemingly high rate of speed. The vehicle then turned right in the lot and parked across aisle from where SCHACK's vehicle was parked. From the footage we noticed the vehicle had four occupants. Three we were able to see were black, and the two that exited the vehicle were males. One wearing a what looked like a varsity jacket that was black with yellow trim and what appeared to be a ski mask. the other wearing a gray/green jacket with a gray hoodie underneath with a red baseball cap with a white logo. The individual appeared to be waiting for less people to be in the lot and then went towards SCHACK's vehicle and were out of frame for 3 minutes. They returned and entered their vehicle and drove off.

With the camera footage we were able to get a license plate of the vehicle. I called SCHACK in case he had not called MPD so they could reach out to us for the video. SCHACK informed me that when he called MPD they said they would send an officer out. I asked for SCHACK to call us when they arrived.

While out on a vehicle patrol, I noticed an MPD enter lot L. I made contact with MPD squad #122 and gave him the suspect vehicle information. MPD officer then gave took my information to send the video and other evidence .
