**Narrative text**

On 4/21/2023 at approximately 0328 while patrolling campus I (Officer Johnson) noticed a car stopped at the corner of 23rd and Butler Pl. I observed the car reverse then drive down the wrong way on Butler Pl. From what I could see it looked like the car was a white sedan but I was not close enough for specific details. I looped around entering Lot B from 21st and heard a car alarm going off. The car was parked in the south part of the lot closer to the entrance by Butler Pl. I noticed it was a white Kia with the driver door open. It was hard to see inside the vehicle but it did not look like anyone was inside. I did not see anyone leave the parking lot so I was not certain that the vehicle was empty. I informed dispatch and requested Officer Allen to meet me in Lot B before approaching the vehicle. I kept an eye on the vehicle from a distance.

When Off. Allen arrived we approached the vehicle and confirmed that it was empty. Dispatch ran the plate and found that the vehicle belonged to Bella Glaser. I took pictures of the damage then went to make contact with Bella. Off. Allen stayed with the vehicle. I made contact with Bella at her residence informing her that someone tried to steal her car. I offered to call MPD for her while she got ready to see her car. Dispatch gave MPD the information who said they would make contact with Bella in the morning. When Bella came down to the lobby I informed her that MPD would get in touch with her in the

I then escorted Bella back to the lobby and continued my vehicle patrol. At approximately 0510 the tow truck arrived and towed the vehicle.
