**Narrative text**

On 4/10/2023 at approximately 1404 I Officer HARTKOPF (127) was doing a routine vehicle patrol when I noticed a vehicle headed eastbound on Butler come face to face with me on the intersection of Butler and 23rd. The vehicle was occupied by three individuals all wearing black/darker color clothing and masks. At first when they saw me from further away they attempted to reverse west on Butler but there was a vehicle behind them. I turned down 23 rd and they drove against traffic on Butler and drove through Lot L. I circled around to 25th where I witnessed them pull out of Lot L and turn right. They continued south on 25th to the first light on Butler/25th. Pulling up a safe distance away not to scare them into driving erratically through traffic I was able to make more details out of the occupants . The passenger rear was wearing a black hoodie with smiley faces down the sleeve in various colors. All appeared to have lighter skin and dark hair.
