Narrative text

I (135) was alerted by the dispatcher that she had a call on the phone reporting damage to a motor vehicle on 21 st Ave in-front of Hagfors, and this was in-progress as the dispatcher was advising me. The report was that there where multiple suspects wearing black or dark clothing, and wearing dark facemask smashing out windows on cars. As I was in-route to this location I spotted a male in lot "D" who appeared to have something in his hand, and walking around a maroon SUV, and this male appeared to be smashing the windows of that vehicle. I notified the dispatcher, and began to head towards lot "D." The suspects noticed me coming towards them, and the ones that were outside of the suspect's vehicle began to

get into that vehicle, and they sped out of the parking lot. I could see a Minnesota license plate on the front of the vehicle, but I was unable to read it because the car was going to fast. I then noticed there was no license plate on the back of the vehicle. I gave the dispatcher a description of the vehicle that drove by me. Officer (140) was already headed south on 21st Ave, and he noticed that vehicle, and he initiated a pursuit of the suspect's vehicle, but lost contact around Riverside near 25th. 140 advice me that the suspect vehicle was driving very reckless and they almost hit city bus and 3 other Vehicle. He also notified me that there were four occupants in the car, two female and two males; all Asian American. As myself, officers 140, where patrolling the campus in the patrol vehicle we noticed other vehicle that had similar damage to them. We all exited the vehicle an began to gather information on this vehicle as we drove around the campus, and we then contacted the dispatcher to get owner/contact information, and we notified the owners to move there vehicle to a safer location for the night. Some chose to move to the underground garages, but others where harder to find. The owner of the maroon SUV later returned to his vehicle to discover the damage. He was working on catering for the "history" event that was going on on campus. MPD was notified, but arrived sometime later, and advised me to advise the vehicle owners to contact them if they wanted to make a report with them.

Also we called 102 for help with all the calls we were getting ask if another officer could be called in for help. He stated to call 130 to see if we want to come in and help. Due to issue with uploading the photos to here, 140 created a folder that can be shared.
