

# I Thought Practicums Were Voluntary...

This workshop introduces field instructors to concepts that inform supervisory strategies for work with involuntary clients: motivational congruence, reactance, and parallel process. With these concepts as context and using scenarios from Chapter 18: Applying the Involuntary Perspective to Supervision in Ron Rooney's 2009 second edition of Strategies for Work with Involuntary Clients (pp. 424-448), participants will explore how to apply contracting skills and address performance issues in supervising students. Issues of safety and cultural competence will also be covered, and there will be interactive opportunities for participants to share examples, raise questions, and bring up concerns emerging in practicums.

#### **OBJECTIVES:**

- Participants will learn to identify involuntary dynamics within field practicums.
- Participants will note, share and discuss potential strategies to use in their practice as field instructors.

This workshop will count toward 3.0 hours of supervision training required for social work licensure.

Tony Bibus is a professor and licensed social worker, and has trained supervisors and been involved with field instruction for twenty-five years. 
