Liability Coverage Made Simple

The required liability insurance for agency internships is now a fee. It will be billed to you along with everything else at the start of the year. The total cost is \$71 dollars (that is one year's coverage \$23 plus your NASW membership, \$48. You have to be an NASW member to get the student rate for the insurance. SABBAT-LOG

(Tony Bibus' Fourth Installment)

Faithful readers of this journal may be wondering what I've been doing on sabbatical besides writing fables and silly songs. "So many books...So little time." That's what it reads in white print on the black coffee cup that I'm sipping from. It's my wife Kathy's cup - she loves to read but hates hot drinks, so I get to use the cup. I thought I'd also get a chance to read several books this fall, and I have read a few, but not as many as I had envisioned now half way through the term. Still, there have been a couple really good ones - I'll review a favorite or two in my final SABBAT-LOG in December.

For this installment and the next, I'll fill readers in on the modest study I've been conducting for the Board of Social Work and what I've learned so far. I've been gathering a list of the practitioners in county social work positions in Minnesota's 87 counties, and I've been able to determine a reasonably sound estimate of the number and proportion of them who are licensed to practice social work. These are important data because social workers in county social service agencies are exempt from licensing requirements, and until now we only had rough estimates of the numbers. I have been curious to know how many county social workers have voluntarily maintained their license, and how many have let their license expire or have not renewed it. And conversely, how many county practitioners in social work positions have never had a social work license? These are timely questions to research because the Board of Social Work is moving to modify the current provision in Minnesota's licensing law that exempts county social workers:

> "The licensing of city, county, and state agency social workers shall be voluntary. City, county, and state agencies employing social workers shall not be required to employ licensed social workers."

(MS 148D.065)

In addition, I've been interested in finding out how this exemption came to be in the first place, so I added historical research to my study and interviewed key informants who were there in 1987 when Minnesota's first social work licensing act was passed, with exemptions.



Minnesota was not alone in adopting a social work licensing statute with particular groups of social workers exempted from at least some of the requirements. In fact, as Troy Elliott from the Association of Social Work

Board (ASWB) has observed, many states whose regulations do not explicitly exempt any social workers actually have "functional exemptions" built into their regulatory structure, for example by only regulating MSW practice or clinical practice. Today, 14 jurisdictions (23%) exempt local government employees and 20 jurisdictions (32%) exempt state employees.

In Minnesota's case, the social work leaders who were pushing for licensure for social workers in 1987 (including an impressive list of 64 professional associations, agencies and client advocacy groups) encountered furious opposition from county social service directors and staff who did not see the need for licensing social workers. Although licensing's primary purpose was to set minimum standards for social workers and provide a recourse for clients whose social workers fell below standards. opponents considered licensing to be a costly duplication of due process and appeal procedures already in place within the human services system. They did not buy that licensing social workers in county settings was intended to protect the public; furthermore, they feared that it would impair agencies' ability to hire staff from a wide pool of qualified individuals with diverse backgrounds including other professions and educational backgrounds in addition to social work. Opponents did acknowledge that clients of non-profit agencies and of social workers in private practice might not have the same protections that are built into government agencies. So, a compromise was struck, and social work licensing became the law in Minnesota with county social workers exempted.

Over the past twenty years though, the Board of Social Work has found that this exemption inhibits the Board's statutory purpose of promoting and protecting the public health, safety, and welfare through the licensure and regulation of persons who practice social work in Minnesota. It has been working to repeal or at least modify the exemption for county social workers. One possibility is that county practitioners who have BSW or MSW degrees would be required to be licensed. To provide similar oversight and standards for the rest of the practitioners in social work positions and to insure that all clients have recourse to the Board in case practice falls below standards, county practitioners who are not eligible for a social work license might be registered (not licensed) as social service professionals. But before developing this idea, we need to know who and how many practitioners it would affect. Thus, I hope my study's findings will prove informative. Stay tuned next time for highlights of what I found out.
