### **BSW Forum Report**

The Forum convened Thursday September 13<sup>th</sup> and set the meeting times and dates for the rest of the term. The next item of business was to review plans for the SWK Get Together and other events in the coming year. 5. New Policy: Mike Schock. SWK 257 assignments vs. other field coursework

I want to put on the agenda for Forum the following policy recommendations: "SWK 257 service learning assignment will be independent from other responsibilities a student might have in a social service agency. For employees in a human service agency, their request to complete the service learning at their employment will be subject to the department policy re: internships and employment. For students currently enrolled in SWK 307 or SWK 407, the 40 hours of service learning will be independent of the internship obligations. "

After debate and feedback it was decided that IF a student is doing both junior field hours and SWK 257 service work hours the tasks have to be appropriate to the difference between volunteer work and pre-professional, insured, social work training. Mike Schock and Nancy Rodenborg, and your course instructors can clarify the difference in tasks.

### Refugee Camp in Loring Park

September 27-30th, 2007 9am to 5:30pm daily Loring Park

Imagine you have just minutes to flee your home. What few items can you carry? How will you find food, shelter, and water? These are just a few of the many thoughts that race through the minds of an estimated 33 million people around the world who have been forced to flee their homes and seek refuge because of war and conflict.

Doctors Without Borders/Médecins Sans Frontières (MSF) hopes to bring an understanding of the refugee experience to the people of Minneapolis. The event is called "A Refugee Camp in the Heart of the City;" a free exhibit open to the general public.

The exhibit is made up of actual materials used by Doctors Without Borders in its medical humanitarian work around the world. The exhibit will highlight the plight of the millions of people currently displaced by conflict in places like Sudan, Colombia, and the Democratic Republic of the Congo, as well as Thailand (the Hmong refugees) and Somalia, where the majority of Minnesota's refugees originate.

One of the benefits of being on sabbatical is the time to think and write. Writing helps with the thinking, too. Writing is also a good way to share one's thinking and invite others to chime in. Please feel free to do so - send your thoughts to Emily for inclusion in Newsnotes.

Four streams of thought have come together for me over the past few weeks. One is reflecting on the collapse of the I-35 bridge on August 1. The second is responding to the shooting of the brother of an Augsburg graduate on August 2. The third is an article by dean of business. And the fourth is the first book that I assigned myself to read on sabbatical, Malcolm Payne's What is Professional Social Work? (2007).

One week after the I-35W bridge collapse, I attended the funeral for Jerren Gabriel Schaden, age 23, who was shot to death on Thursday, August 2, 2007, in our city, his home. His older brother, Tony, an Augsburg College graduate, read these lines from the memorial poem that his sister Jerrina wrote for Jerren:

"Someone once told me you live to die. But life was taken from him. My brother didn't live enough to die."

I wished that the community solidarity manifested in response to the highway tragedy also would focus with righteous outrage on the daily disaster of violence that our children face in their neighborhoods, where they deserve safety. Steve Cramer, Executive Director of Project for Pride in Living, has called for a stronger collective will to confront what he calls the "quiet community tragedies of spreading and deepening poverty, violence, and employment and educational disparities" (Notes from the Executive Director, PPL newsletter, February-August 2007, p. 2). He puts the call eloquently: "As we see a new bridge rising from the wreckage, and remember the many selfless individual acts during that horrible time, let us be inspired to address with equal vigor and purpose our quiet community tragedies."

Social work has an important role in this effort. In a commentary published in the Star Tribune business section (August 8, p. D8) Christopher Puto, Dean of the College of Business at St. Thomas, wrote about how successful businesses and non-profit agencies give top priority to "identity processes." These are activities that define the organization – for example, he explained how FedEx makes "on-time delivery" its top priority because that defines their business. In social work, our identity processes probably relate to service, human rights, and social justice; this is where reading Payne's book helped clarify my thinking. He's reflecting on a lifelong career in social work, with lots of international connections and an extensive record of publications on social work theory and philosophy; so his is a useful take on what our identity as social workers could be. His main point is that social workers, their clients, and society co-construct social work as they interrelate with each other – social workers show the social work process in our interpersonal work, which in turn is valued by other professionals and service users. Although difficult to put in a nutshell, social work's complex identity is nevertheless its strength, and it is "unique in its particular combination of the social and the psychological with its values and objectives" (p. 189).

Payne writes further: "Looking across different countries, therefore, we can identify a variety of different social works, with a range of roles. However, we can also identify continuities, and these continuities lie in the claim to connect the interpersonal with the social and the social with the interpersonal" (p. 175). Several other social work scholars (for example Paul Stuart in his article "Bridging Borders: How Social Workers Build Ties and Transform Relationships" in The Journal of Baccalaureate Social Work, vol. 12, no. 2, pp. 13-25, spring 2007, and Kay Hoffman and Alvin L. Sallee in their 1994 text Social work practice : Bridges to change) have used a bridge metaphor to claim social work's identity as the profession that creates spans between people, resources, other professions, communities, and each other.

That reminds me of the fable of the bridge tenders – but that's my SABBAT-LOG's topic for the next Newsnotes. Talk to you then!
