1. Open Forum

a. William Mullen and Rick Ellis spoke about enrollment trends for Day undergraduate students.

2. Approving Minutes

- 3. Governance Updates
  - a. President
    - i. Jim and Mark meet with the President in early December.
  - b. Leadership Council
    - i. Nothing to report.
- 4. Committee Updates
  - a. Diversity & Inclusion
    - i. Student Survey
      - 1. The survey had a 16.5% response rate, which was good.
      - 2. The consulting group running the survey will have the results ready by January 1, 2015.
  - b. Risk Management
    - i. Changed the name from the Safety Committee to the Risk Management Committee.
    - ii. Individuals working with individuals who have been sexually assaulted need to be trained around working with traumatized individuals.
    - iii. 5 people have done slip and fall claims; Facilities is trying to be strategic around removing snow and ice.
    - iv. Faculty members need to be trained around what to do when a student is having a seizure.
    - v. There will be a training on Incident Command on December 11.
  - c. Budget and Finance
    - i. There is a meeting on November 24.
